

OFFICIAL RULES

Photo Contest

SPONSOR. The Contests are sponsored by GalleryCollection.com, 65 Challenger Road, Ridgefield Park, NJ 07660

ELIGIBILITY.

1. This contest is open to legal residents of the fifty (50) United States and the District of Columbia, as well as American Samoa, Guam, the Commonwealth of the Northern Mariana Islands, the U.S. Virgin Islands, and Puerto Rico.
2. Applicants must be 18 years of age or older at the time of entry, unless prohibited by law.
3. Employees of Sponsor, their family members, and persons living in the same household as employees or their family members are not eligible.
4. No purchase is necessary to enter the contest.
5. Void where prohibited by law. The Contest is governed by U.S. law and is subject to all applicable federal, state, and local laws and regulations.
6. No prize will be awarded to applicants who do not meet the eligibility requirements. All information on the application must be accurate and complete.

TIMING. Each Competition will be separately identified by GalleryCollection.com at www.gallerycollection.com/photo-contest by a specific call for submission of Materials accompanied by any evaluation criteria, opening and closing time for submissions, and awards that will be issued for each Competition (the "Competition Details").

GalleryCollection.com, in its sole discretion, may shorten or extend any opening or closing times for submissions and may supplement any evaluation criteria or awards or other Competition Details. All entries must be submitted as required in the Competition Details. An entry constitutes acceptance of these Official Rules.

AGREEMENT TO OFFICIAL RULES. Participation in the Contest constitutes applicant's full and unconditional agreement to and acceptance of these Official Rules. By entering the Contest, applicant warrants that the submission is an original work, has not been previously published or won any award, and that applicant is aware of no conflicting rights in the submission including but not limited to copyright or other intellectual property right as further identified below in the section entitled "No Infringement." Applicants agree that Sponsor, its affiliates, parents, subsidiaries, agents

or contractors and their employees, officers and directors shall not be liable for injury, loss or damage of any kind resulting from participating in this Contest.

ORIGINALITY; NO INFRINGEMENT. All photographs must be the original work of the applicant. All applicants represent, state, and agree that their Contest submissions will not infringe upon the intellectual property rights of any third party, including by way of example and not by limitation, any copyright, trademark or patent rights belonging to any third party. Plagiarism in any form will result in disqualification. No professional photography permitted.

PUBLICITY; USE OF NAME AND LIKENESS. Except where prohibited by law, entry in the Contest constitutes each applicant's consent to the Sponsor's use of his or her name, city and state of residence, entry, likeness, photograph, and image for advertising, publicity, and promotional purposes in any media, online or offline, without further permission, consent, payment or other consideration.

USE OF PHOTOGRAPHS. All winning and non-winning photographs submitted remain the property of the applicant. GalleryCollection.com shall have the right to use said photographs for publicity or as content in any media, online or offline, without further permission, unless prohibited by law.

NOTIFICATION OF WINNER. Winner will be notified upon completion of the voting process.

GENERAL TERMS AND CONDITIONS. Winning is contingent upon fulfilling all requirements of these Official Rules and Sponsor's decisions as to the administration of the Contest and prize awards are final. Sponsor will notify the potential Winner in accordance with the information provided by applicant in the Contest entry. The potential Winner must sign and return (1) a Declaration of Eligibility and a Publicity/Liability Release (except where prohibited by law) within five (5) days of receipt of those documents or the prize may be forfeited. In the event that any prize notification is undeliverable, Sponsor is unable to contact a potential winner, or response to a prize notification is not received within five (5) days of its issuance, the prize may be forfeited. Where a prize is forfeited, the applicant with the next best overall qualifications in accordance with the Judging Criteria will be chosen as an alternate Winner.
